SUMMARY OF INFORMATION:

The purpose of this Special Revenue Fund Amendment is to appropriate \$12,099.39 of Emergency Telephone System Special Revenue Funds from a prior year (FY2016) encumbrance for the purchase of new 800MHz radios for the Forsyth County backup Public Safety Answering Point (PSAP).

A purchase order (PO160383) was initiated in May 2016, but the equipment was not received until after the fiscal year had closed (August 2016) triggering a prior year encumbrance roll-over into the new fiscal year.
