RESOLUTION AWARDING A CONTRACT FOR THE PURCHASE OF TWO 2019 DODGE DURANGO PURSUIT SUVS (FORSYTH COUNTY SHERIFF'S OFFICE)

WHEREAS bid invitations for two 2019 Dodge Durango pursuit vehicles to be utilized by the Forsyth County Sheriff's Department were issued directly to a total of twelve qualified businesses; and

WHEREAS after due advertisement, bids were received and publicly opened by the City/County Purchasing Department at 12:00 Noon, on Wednesday, July 25, 2019, for the purchase of two all-wheel drive 2019 Dodge Durango Pursuit SUV'sat the request of the Forsyth County Sheriff's Office and the following bids were received:

WHEREAS the bid offered by Performance Automotive Group, Inc., is provided through the North Carolina Sheriff's Association Group Purchasing Program, a formally organized competitive bidding group purchasing program that offers discount prices to public agencies, compliant with N.C.G.S. 143-129(e)(3);

WHEREAS it is the recommendation of the County Manager, the County General Services Director, and the City/County Purchasing Director that a contract for the purchase of two all-wheel drive 2019 Dodge Durango Pursuit SUVs per bid specifications in the amount of \$30,733 each be awarded to Performance Automotive Group, Inc.for atotal amount of \$61,466; and

WHEREAS the County Chief Financial Officer has determined sufficient funds are available to cover the cost of these contracts;

NOW, THEREFORE, BE IT RESOLVED, by the Forsyth County Board of Commissioners, that a contract for the purchase of two all-wheel drive 2019 Dodge Durango Pursuit SUV's per bid specifications for \$30,733 each is hereby awarded to Performance Automotive Group, Inc., in the total amount not to exceed \$61,466 and that all other bids are hereby rejected; and

BE IT FURTHER RESOLVED, that the County Manager and Clerk to the Board are hereby authorized to execute a contract, on behalf of Forsyth County, with Performance Automotive, Inc. for the purchase of twoall-wheel drive 2019 Dodge Durango Pursuit SUVs consistent with the terms outlined herein, subject to a pre-audit certificate thereon by the County Chief Financial Officer, if applicable, and approval as to form and legality by the County Attorney.
